

DELINQUENCY ASSISTANCE

The US Department of Veterans Affairs urges all Veterans who are encountering problems making their mortgage payments to speak with their loan service officer as soon as possible to explore options to avoid foreclosure. Contrary to popular opinion, service officer really do *not* want to foreclose because foreclosure costs a lot of money. Depending on a Veteran's specific situation, service officer may offer any of the following options to avoid foreclosure:

- Repayment Plan The borrower makes regular installment each month plus part of the missed installments.
- Special Forbearance The service officer agrees not to initiate foreclosure to allow time for borrowers to repay the missed installments. An example would be when a borrower is waiting for a tax refund.
- Loan Modification Provides the borrower a fresh start by adding the delinquency to the loan balance and establishing a new payment schedule.
- Additional time to arrange a private sale The service officer agrees to delay foreclosure to allow a sale to close if the loan will be paid off.
- Short Sale When the service officer agrees to allow a borrower to sell his/her home for a lesser amount than what is currently required to pay off the loan.
- Deed-in-Lieu of Foreclosure The borrower voluntarily agrees to deed the property to the service officer instead of going through a lengthy foreclosure process.

Veterans with VA-Guaranteed Home Loans: The service officer has the primary responsibility of servicing the loan to resolve the default. However, in cases where the service officer is unable to help the Veteran borrower, Loan Guaranty has Loan Technicians in eight Regional Loan Centers and a special servicing center who take an active role in interceding with the servicer to explore all options to avoid foreclosure. Service members or Veterans with VA-guaranteed home loans can call (877) 827-3702 to reach the nearest Loan Guaranty office where Loan Specialists are prepared to discuss potential ways to help save the loan.

Veterans with non-VA Guaranteed Home Loans: For a Veteran or service member who may have obtained a conventional or sub-prime loan, VA does not have the legal authority to intervene on the borrower's behalf. It is imperative that a borrower contacts his/her service officer as quickly as possible. Visit VA's website (http://benefits.va.gov/homeloans/) or call toll-free (877) 827-3702 to speak with a VA Loan Technician for advice on approaches to take with your service officer.

National Call Center for Homeless Veterans: Veterans who feel they may be facing homelessness as a result of losing their home can call (877) 4AID VET (877-424-3838) or go to http://www.va.gov/HOMELESS/NationalCallCenter.asp to receive immediate assistance from VA.

Other Assistance: In addition to the resources offered by VA, the Department of Housing and Urban Development (HUD) offers assistance to homeowners by sponsoring local housing counseling agencies. INCARCERATED VETERANS

VA benefits are affected if a beneficiary is convicted of a felony and imprisoned for more than 60 days. Disability or death pension paid to an incarcerated beneficiary must be discontinued. Disability compensation paid to an incarcerated Veteran rated 20% or more disabled is limited to the 10% rate. For a Veteran whose disability rating is 10%, the payment is reduced to half of the rate payable to a Veteran evaluated as 10% disabled.

Any amounts not paid to the Veteran while incarcerated may be apportioned to eligible dependents. Payments are not reduced for participants in work-release programs, residing in halfway houses, or under community control. Failure to notify VA of a Veteran's incarceration can result in overpayment of benefits and the subsequent loss of all VA financial benefits until the overpayment is recovered. VA benefits will not be provided to any Veteran or dependent wanted for an outstanding felony warrant.

The Health Care for Re-entry Veterans Program (HCRV) offers outreach to Veterans incarcerated in state and federal prisons, and referrals and short-term case management assistance upon release from prison. The Veterans Justice Outreach Program (VJO) offers outreach and case management to Veterans involved in law enforcement encounters, overseen by treatment courts, and incarcerated in local jails. Visit www.va.gov/homeless/ to locate an outreach worker. The Veterans Justice Outreach (VJO) Program offers outreach and linkage to needed treatment and services to Veterans involved in law enforcement encounters, seen in the court system, and/or incarcerated in local jails who may be at risk for homelessness upon their release. Visit www.va.gov/VJO.asp to locate a Veterans Justice Outreach Specialist. The Health Care for Re-entry Veterans (HCRV) Program offers outreach, linkage to needed treatment and services, and short-term case management assistance for Veterans incarcerated in state or federal prison that may be at risk for homelessness upon their release. Visit www.va.gov/homeless/reentry.asp to locate a Re-entry Specialist.

FIRST FEMALE QUILT OF VALOR RECIPIENT

The Anderson Senior Citizen Quilters, in conjunction with Chapter #63 (Clermont County) of the Disabled American Veterans (DAV) presented a "Quilt of Valor" to Lisa Wilson, a disabled Army veteran on November 10, 2015. The presentation was made by Ms. Mary Bartels, chief instructor of the quilters, at the Anderson Township Senior Citizen Center.

Although this was the fourth "Quilt of Valor" given to disabled veterans by the Anderson Quilters, this presentation was the <u>first</u> "Quilt of Valor" presented to a female disabled veteran. "To my knowledge, this is the first 'Quilt of Valor' presented to a female soldier in the southeastern Ohio region," said Ms. Bartels.

The quilts are presented to disabled veterans as a comforting and healing gesture of appreciation from quilters. The concept of presenting quilts to soldiers is rooted in the Civil War tradition of family members giving departing soldiers homemade quilts made from pieces of their families' own clothing to comfort the soldiers in their times of need and strife.

Women have served in the military since the American Revolution. The first woman honored by the military was Mary Ludwig Hayes, who was nicknamed "Molly Pitcher." General George Washington saw her manning the ramrod and cleaning a cannon

after her husband, John Hayes, collapsed from heat exhaustion at the Battle of Monmouth. After the Battle of Monmouth was won by the Continental Army, Washington commissioned her as a Sergeant in the Proctor's 4th Pennsylvania Artillery. Today, a statute of "Molly Pitcher" with a cannon ramrod in her hands at the Monmouth battlefield in New Jersey.

Today, women serving in the military constitute 20 percent of new recruits and 14.5 percent of the 1.4 million active duty military personnel. Females constitute 18% of Reserve Components in the military. Approximately 280,000 females served post-9/11 in Afghanistan and Iraq. Although projected male recruits will decline in 2020, female recruits will increase by 11%.

"Historically, contributions made by women to the military have not been fully recognized," said John Plahovinsak, Commander of DAV Chapter #63 (Clermont County). "A recent DAV sponsored survey, the DAV Veteran Pulse Survey, substantiates this perspective by both females and males."

The DAV was one of the first veteran organization to recognize that the unique needs of female veterans are both varied and complex. It commissioned two studies (*Stand Up for Women Veterans* and *Women Veterans: The Long Journey Home*) in 2014 to serve as an action blueprint to explore the issues facing women as they transitioned from military to civilian life. The overarching goal of these two studies was to document the existing gaps in federal programs and services and to spur policy changes to fill them.

"I think that it is fitting and proper that the Anderson quitters recognize Acting Sergeant Lisa Wilson as the recipient of this 'Quilt of Valor' today," explained DAV Chapter #63 (Clermont County) Adjutant Raymond Hutchinson. "Hopefully more women in the future will be recognized for their efforts while serving on active duty in the military."

Acting Sergeant Wilson served as a Wire System Installer during her three years of military service with the 4th Battalion of the 1st Signal Brigade at Fort Gordon, Georgia. She explained that her military job was as a "pole climber" who installed wire for communications. While at Fort Gordon, she was promoted to the position of assistant to the Operations Sergeant of the Battalion, and earned an Army Commendation Medal before her medical discharge.

Wilson accepted the "Quilt of Valor" not for herself, "but for all the disabled women veterans whose military achievements and contributions were never recognized." She noted, "I will hang this quilt proudly on the wall of my office so that all who enter will see the honor bestowed upon me by the Anderson quilters. If any disabled veteran that I'm serving needs to hold the quilt, I will gladly wrap it around their shoulders."

Both she, and her service dog, are employed as a Department (of Ohio) Service Officer (DSO) by the Disabled American Veterans. "My job is to listen to veterans, prepare their disability claims to the Veterans Administration (VA) and process them in a timely manner," explained Wilson. "The DAV prepares and processes 70% of all VA disability claims for veterans free of charge, and it is my job to see that they are done correctly on behalf of the veterans."

Commander Joyce Hutchinson, of the DAV Auxiliary Chapter #63 introduced the main speaker for the presentation, Ms. Tracey Butts, who is in charge of Voluntary Services at the Cincinnati Veterans Administration Medical Clinic (VAMC).

Ms. Butts explained how she witnessed the therapeutic efforts of quilts placed on the shoulders of disabled male and female veterans, who were suffering post-traumatic stress disorder (PTSD) syndrome effects. She provides one quilt to each of the female disabled veterans residing at a Fort Thomas annex of VAMC. Several female veterans related to her how much the quilt that they were given meant to them as a part of their healing process.

Ms. Butts' Voluntary Services work also included serving pregnant Army veterans with a basket containing a baby quilt and new baby-related items. During her presentation, Ms. Butts recognized the efforts of Commander Joyce Hutchinson of the DAVA Chapter #63 (Clermont County) in providing supplies for the baskets.

Following the oral presentations, all the Anderson Senior Citizen Quilters gathered around Ms. Wilson and wrapped the Quilt of Valor around her in a healing and comforting gesture.

Past Department of Ohio Commander Raymond Hutchinson concluded the presentations by giving Ms. Wilson an Army baseball cap with a 2015 DAV pin to celebrate the day, on behalf of DAV Chapter #63 (Clermont County).

In her final comments, Ms. Bartels commended all the husbands of the quilters, who attended the presentation and DAV Chapter #63 (Clermont County). She also announced that the Anderson Senior Citizen Quilters were already working on a fifth "Quilt of Valor" to be presented to another worthy disabled military veteran in the near future.

ATTENTION CHAPTER OFFICERS!

The Department of Ohio wants your Chapter to succeed, that's why when your Chapter files your annual Financial Report with National and Department Headquarters, we at the Department will file your form *990-N* also known as the *e-Postcard* with the IRS as long as your Chapters annual gross receipts are \$50,000 or less.

If you do not file your *e-Postcard* on time, the IRS will send you a reminder notice. There is no penalty assessment for late filing the *e-Postcard*, but an organization that fails to file required *e-Postcards* (or information returns – Forms 990 or 990-EZ) for three (3) consecutive years will <u>automatically lose its tax-exempt status</u>. The revocation of the organization's tax-exempt status will not take place until the filing due date of the third year.

If you prefer to file the form 990-N (e-Postcard) yourself please feel free to do so. We just ask that you send a copy of the form to the Department Headquarters at *P.O. Box 15099, Columbus, Ohio 43215-0099 to the attention of Stephanie Williamson.*
