# **DAV Department of Ohio Officers & Members**

It is difficult to keep up with current, ever changing circumstances, rules and restrictions. We hope that this message reaches you while our advice is valid.

#### **CHAPTER MEETINGS – ELECTIONS OF OFFICERS**

DAV chapter meetings should be held only if they do not violate the Governor's Orders. Those Orders continue to prohibit meetings of more than ten persons & mandate that attendees stay six or more feet from one another, with masks worn by officers. In certain counties, masks are required on all attendees. When meetings are resumed, sick members should stay home and rest and recover.

Holding chapter elections on a different month than that prescribed by the chapter bylaws requires a special meeting. Special meetings require notice to all chapter members. To assist chapters in conducting special meetings for elections, Department Headquarters offers to alert all members of each chapter, by postcard, of the date, time and location of a chapter's special election meeting. Chapter Commanders or Adjutants may contact Department Headquarters six weeks or more prior to the planned meeting to request our preparation and mailing of such postcards.

#### SERVICE CONNECTED DISABILITY CLAIMS - OTHER BENEFITS ASSISTANCE

The DAV Cleveland National Service Office is located in the Federal Building in Cleveland. That building remains closed to the public, leaving our office unavailable. However, DAV NSOs are working remotely and can be reached by calling 888-604-0234 or by computer at www.benefitsquestions.org.

Claims & other benefits assistance also is available through our Department Service Officers (DSOs). DSO offices are located in VA medical facilities, where they are subject to local VA rules. Some facilities currently deny entrance to all but those with medical appointments. Some DSOs have met veterans at their building parking lots to obtain documents & signatures.
